In election years, the HBA conducts a Judicial Candidate Qualification Poll and a Judicial Preference Poll to determine for which candidates its members would vote in the primary and general elections. To be included on the Judicial Evaluation Questionnaire, judges must have served on their current court for a minimum of six months as of December 31, 2010.
